Latest COVID-19 measures come into force today

The latest COVID-19 decisions and measures based on recommendations made by the Higher Committee for Infectious Diseases came into force on Monday.

According to the latest decisions, the 12 midnight to 5am curfew remains in place from Monday to Sunday.

No changes have been introduced to the opening and closing hours of retail shops, supermarkets and other sectors.

Accordingly all retail stores and sectors which are open will be allowed to operate between 8:30 am and 9 pm.

Restaurants, cafes, patisseries, taverns and other eateries will be allowed to open from 6 am to 11:30 pm.

Supermarkets will be open between 7 am and 11:30 pm.

The number of daily flights allowed into the country has been increased to ten while the limit to two ferries per day remains in place. However, the ferries will be allowed to transport a maximum of 250 passengers each.

Tourists arriving via charter flights who wish to extend their five-day stay in the TRNC will be able to do so by renewing their PCR tests.

The countries listed under different colour codes have been updated and can be accessed through the health ministry's website.

All passengers arriving from the following countries where the delta variant of Covid-19 has been detected will be required to undergo PCR testing upon arrival irrelevant as to whether or not they have been fully vaccinated.
